Please Initial each Item that you've read, comply with, and understand the requirements. Items in **RED** are mandatory.

- **Liability Waiver Signed** – Every occupant of every vehicle participating in the trail ride must sign the liability waiver, including minors. See attendant for questions.
- **Vehicle Insurance** – Proof of vehicle liability insurance required – no exceptions. No Proof – no participation. Must meet minimum requirements for legal road use.
- **Fire Extinguisher** – Required on private trails in each vehicle. Type ABC 2lb min. Must be mounted or secured in the vehicle. Prefer to be mounted within reach of the driver seat.
- **Tow Points** – Front and rear tow points are in safe working order for recovery operations.
- **First Aid Kit** – Each vehicle should carry a basic first aid kit.
- **Substances** – Drivers are free of alcohol/drugs or other substances that may otherwise inhibit the ability to safely operate the vehicle on trails or roads.
- **Seat/Seat Belts** – Seats must be securely mounted. Seat belts are required for all occupants. All occupants must wear their seat belt at all times while in the vehicle.

PLEASE PHYSICALLY CHECK THE ITEMS ON YOUR RIG AND CHCK THEM OFF AFTER INSPECTION

- **Tires/Lugnuts** – must have all lug nuts installed and secured properly. Tire tread and rims are legal for road use and safe for trail use.
- **Battery** – Must have OEM equivalent or stronger. The battery cannot move and must be secure.
- **Brakes** – Must have front & rear brakes. Line must be secured to the axle and/or frame. The pedal cannot be spongy or sink to the floor. Brakes must have pressure. No excessively dangling brake line appearing to be susceptible to snagging on trail obstacles or debris.
- **Oil/Fluids** – fluids are of proper levels and safe for vehicle operation. No leaks of any fluids.
- **Controls/Cables** – All controls, cables, and wiring are property secured and functioning safely.
- **Frame/Rollbars** – All frame and roll bars are safe for legal road use and trail operation. The underside of the vehicle has been checked for loose parts, bolts, and broken welds.
- **Lights/Electric** – All electrical components are fully functioning for legal and safe operation.
- **Exhaust** – Must have a USFS/DOT spark arrestor in the muffler and exhaust sound is under noise level required for legal road use.
- **Winch** – If the vehicle is equipped with a winch, the line and motor, along with all connections have been inspected and tested to be working properly.
- **Suspension** – Suspension is in safe working order for trails and is legal for rode use.
- **Windows/Glass** – Windows and glass are in safe working order and compliant for legal road use.
- **Cargo** – All coolers, tools, spare tires, jacks & cargo is secured/strapped down.
- **Gear** – Vehicle has adequate gear for everyone inside to deal with climate, food, thirst, and rest stops.
